

By registering to participate as a Golfer or team of golfers in the 2019 Swing to Bust Cancer Golf Tournament, you are agreeing to these Terms and Conditions which form a legally binding agreement between the National Breast Center Foundation (NBCF) and the Golfer. There will be a shotgun start for the golf tournament at 1:00 pm on May 6, 2019.

1. Registration. All registrations must be completed online using the Swing to Bust Cancer Give Gab Registration Portal. Email confirmations will be sent by Swing to Bust Cancer organizers within 3 business days to confirm successful registration. Swing to Bust Cancer organizers must receive Golfer registration by May 3, 2019. Golfer must provide any requested information to tournament organizers as needed so organizers may forward player information to Belle Haven Country Club.
2. Cost. The entry fee for each Golfer is \$300.00 per person / \$1200 per foursome. This includes greens fees, golf cart rental, practice range facility use, boxed lunch, beverages on course and cocktail reception following play.
3. Payment. Payment may be made online using the registration system via credit card.
4. Compliance with Belle Haven Country Club Rules and Regulations. All Golfers must comply with Belle Haven Country Club Rules and Regulations, including pace of play, golf shoes, dress code, and any other policies in place. Acceptable attire includes: Collared shirt (tucked in for men), long pants or appropriate shorts. Wearing headgear in the Clubhouse is NOT permitted. Unacceptable attire: T-shirt, tank top, athletic shorts, denim or cut-offs. No metal spikes: Soft spikes are available at the Pro Shop for a fee.
5. Golf Carts Rules. Each Golfer agrees: To return the golf cart immediately following the specified number of holes of play on the course. To pay for any damages to the assigned cart, above and beyond normal wear. To drive slowly and use caution due to varying terrain (slopes and hills) and/or conditions, never operating the golf cart while in neutral. The Golfer represents that he/she is familiar with the safe operation, use, and control of the golf cart and that he/she will abide by the instructions appearing on the golf cart. To not allow unauthorized persons or anyone without a valid driver's license to operate the golf cart. To carefully obey all signs and warnings on the golf course directing operation of the golf cart whether by posted sign or by verbal instructions given by a Country Club employee.
6. Indemnification.
 - a. Golfer agrees to indemnify, defend, and hold harmless NBCF, its affiliates, and their respective employees, directors, officers, and agents, from any and all liabilities, losses, damages, costs and expenses (including reasonable attorney's fees) due to, arising from, or in connection with any third party claim, suit, judgment, or proceeding alleging: i) any breach by Golfer; or ii) any negligent or wrongful conduct committed by Golfer pursuant to or in performance of this Agreement.
 - b. Golfer is liable for any damage caused to International Country Club property, including damages to the golf course, golf carts, golf equipment, golf clubs, and the like.
7. No Refunds. THERE ARE NO REFUNDS FOR CANCELLATIONS BY GOLFERS FOR ANY REASON. IF A GOLFER CANCELS AT ANY TIME, FOR ANY REASON, THE GOLFER WILL REMAIN RESPONSIBLE FOR PAYMENT OF THE ENTIRE GOLF ENTRY FEE.
8. Media Release By participating in the event, you agree to the use of your likeness and image by NBCF in all future marketing and promotional materials.
9. Governing Law This Agreement shall be governed by and construed in accordance with the laws of the State of Virginia. NBCF and Exhibitor are that the state courts of Virginia and the federal courts located in the State of Virginia shall have exclusive jurisdiction and venue to adjudicate any and all disputes arising out of or in connection with this Agreement.
10. Amendments to Terms and Conditions. These Terms and Conditions may be amended at any time for any reason by NBCF with or without notice to Golfer, and all amendment so made shall be binding on Golfer.

GOLFER ACKNOWLEDGES AND AGREES that by registering for the 2019 Swing to Bust Cancer Golf Tournament, they have read these Terms and Conditions and understand that this Agreement is legally binding between NBCF and Golfer.
